- Eight residents moved to a more independent living setting

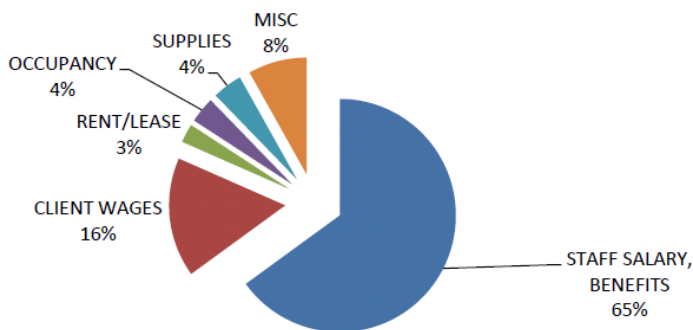

Financials 2011

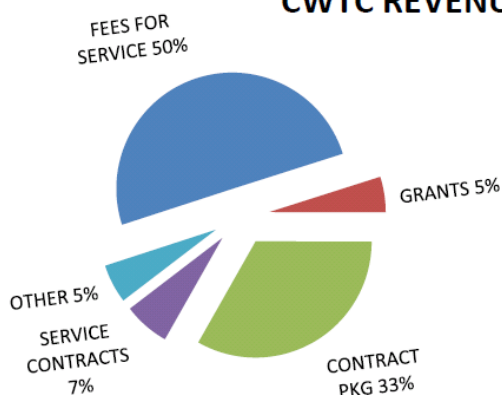
Total Expense: \$7,488,000
