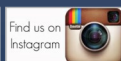

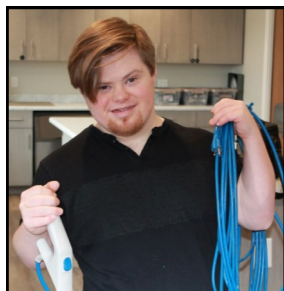

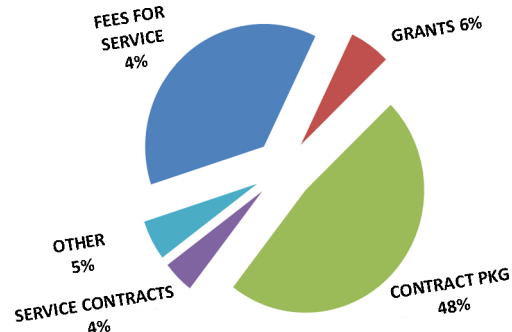
Organizational Employment

- Consumers earn a paycheck and are learning to be productive citizens in their community.

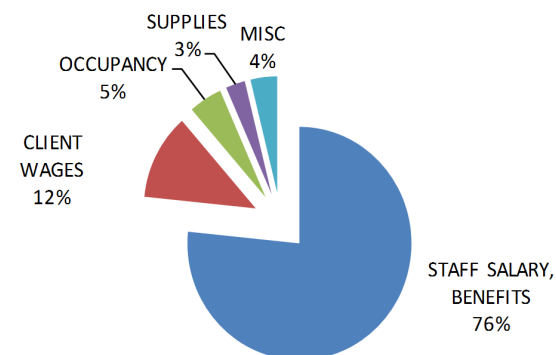

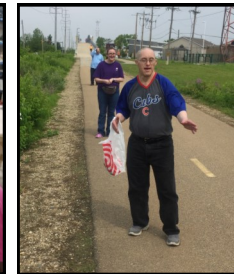
